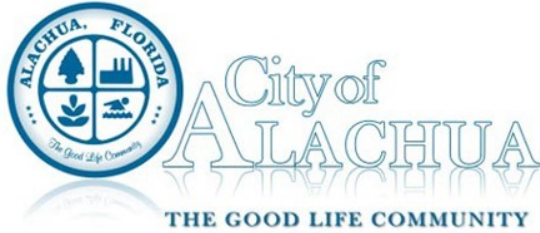

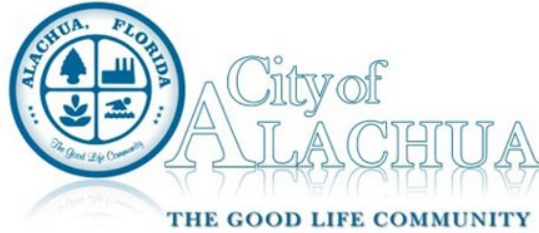

C) FUTURE PROJECT/INITIATIVE IDEAS

Recreation and Culture Assistant Director Jack Hansen gave a presentation talking about the Youth Council Excellence Award. The award is granted by the Florida League of Cities on an annual basis to a chosen municipal youth council in Florida. The award celebrates exemplary municipal youth council projects or initiatives that have made significant contributions to their municipality.

Members discussed ways in which the Youth Advisory Council could positively impact the community and contribute to the well-being of the citizens of Alachua. Ideas on how to help the community included more focus on mental health, recycling, and hurricane disaster relief.

More discussions ensued with the decision being made to table the decision on which direction to take until the next meeting when there are more members present.

Member Wilson moved to put the mental health and the recycling topics for the project on the next meeting agenda, seconded by Member Liu.

Passed by 3-0 roll call.

D) FUTURE FIELD TRIPS OR EVENTS

Recreation and Culture Assistant Director Jack Hansen gave a presentation on the Legislative Action Days in March 2025. The Legislative Action Days allow youth to travel to Tallahassee and see the state legislature, allowing them access to an experience that can strengthen their interest in government and teach them more about how

government works.

Due to the next scheduled meeting taking place after the proposed times for the trip, it was decided that the logistics for the trip will be handled in the coming days by Recreation and Culture Assistant Director Jack Hansen.

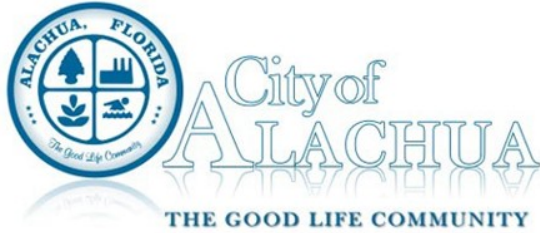
