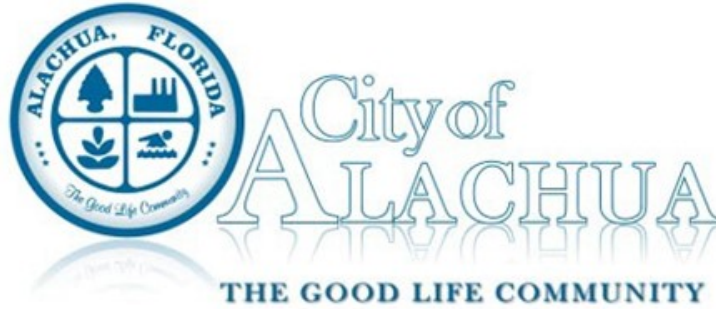

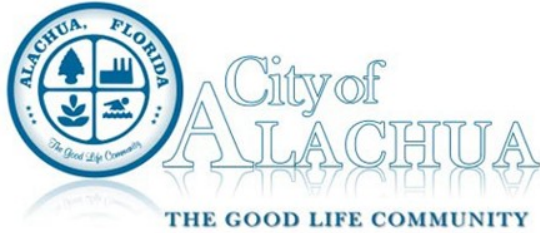

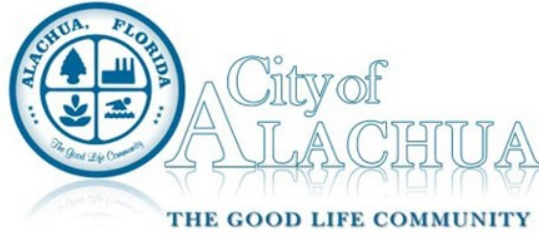

Member DaRoza moved to adjourn; seconded by Member Sherman.

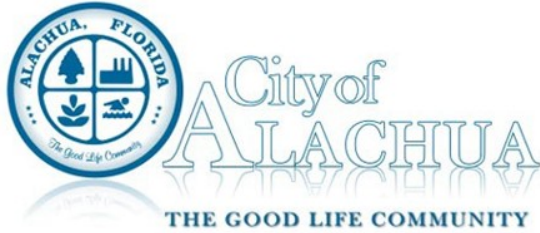

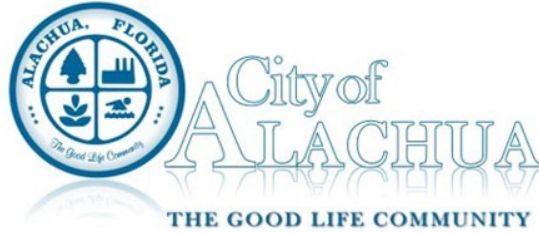

Member Sherman moved to approve the reading of proposed ordinances and resolutions by title only; seconded by Member DaRoza.

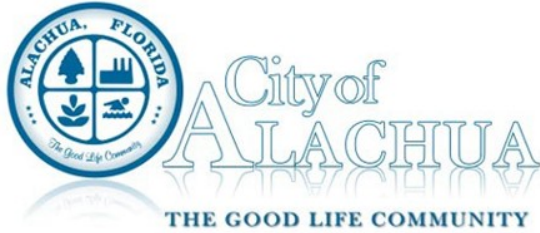

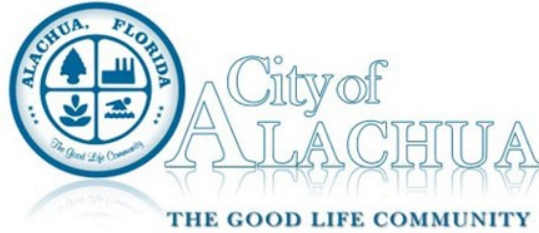
