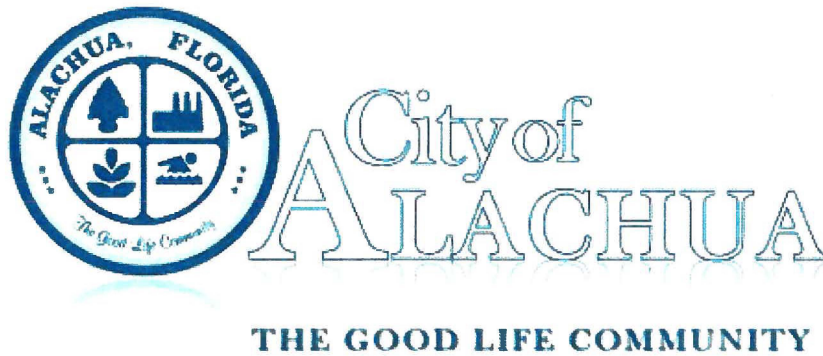

Questions were posed by the commissioners.

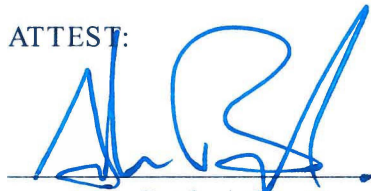
