None.

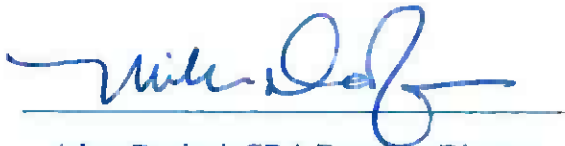
