B. Wayfinding Sign Idea Generation Workshop

CRA Coordinator Chelsea Bakaitis introduced the item.

Melinda Dickens, Senior Project Manager with CHW, provided a presentation, discussed the Wayfinding System Master Plan, and availed herself for comments and questions.

Member Harris suggested medical/urgent care and lodging signage be included on wayfinding signs and discussed signage at the I-75/ US Highway 441 interchange.

Member Robertson inquired about the visibility of signage from I-75 and US Highway 441.

Member Bingham inquired about the integration of technology and mobile apps for wayfinding.

Chair Rothseiden suggested different types of signage and interchangeable signage options.

Member Harris suggested having signage to direct patrons from Legacy Park and Hal Brady Recreation Center to downtown Alachua. She also suggested adding public parking signage and other informational signage throughout the City.

Member Robertson suggested an electronic message board for events.

Chair Rothseiden opened the floor up for questions and comments.

Rachael Westhood, with One Stop Urgent Care, requested signage pointing to their business.

Gib Coerper discussed federal signage for historic districts on I-75 and at entry points to the historic areas.

Diana Carlson discussed Google Maps labels and ways to use social media to engage the public. She also suggested tree trimming on Main Street due to limited visibility.

Melinda Dickens responded and thanked the Board and public for their input.

Chair Rothseiden discussed the need for consistency in signage and the use of the CRA/Main Street logos.

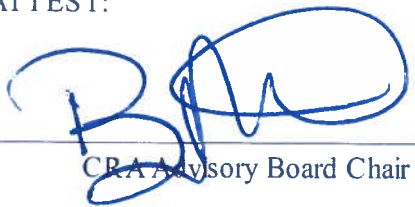
