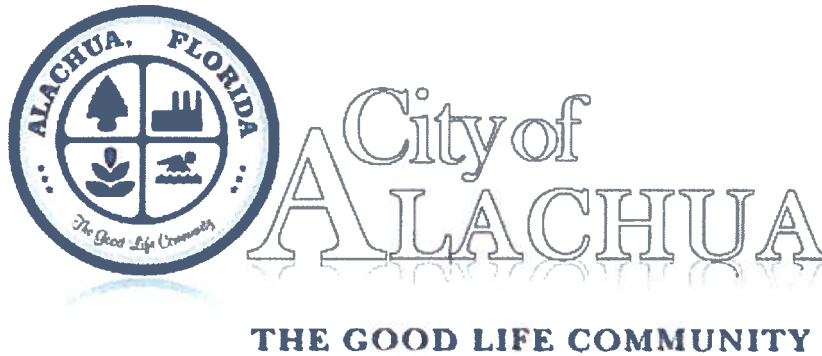

Rick Robertson commented about the Third Thursday events, the number of properties for sale on Main Street, and his support for communication with CRA businesses.

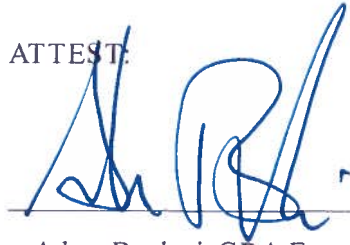
Executive Director Boukari responded to the discussion.
