Member Wilford moved to adjourn; seconded by Member Miller.

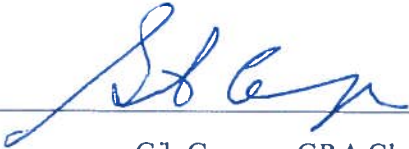
