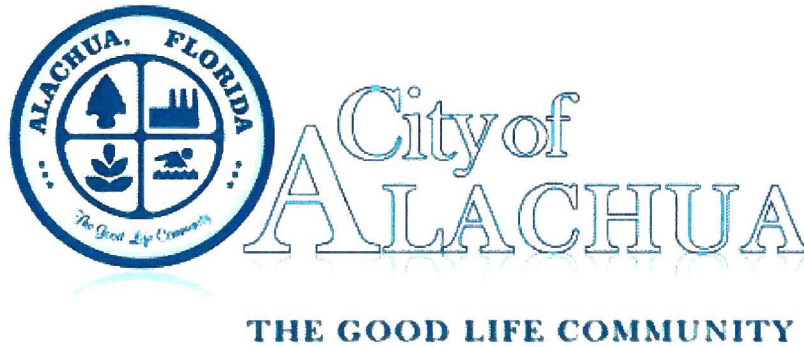

Resolution 18-11: Amending the Fiscal Year 2017-2018 Budget for the receipt of unanticipated revenue; Increasing the Community Development Block Grant (CDBG) -Neighborhood Revitalization (NR) Capital Project Fund to appropriate revenues and expenses related to the Department of Economic Opportunity (DEO) Subgrant Agreement - FFY16 Funding Cycle in the amount of \$750,000**

Passed by unanimous consent.

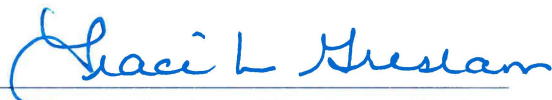
