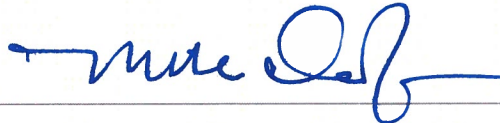
Member Thomas moved to adjourn the meeting; seconded by Member Varnell.
