Executive Director Boukari asked Ms. Harris if she could share any insight into what business owners would like to receive from City events.

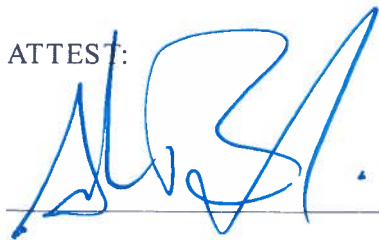
Ms. Harris responded.
