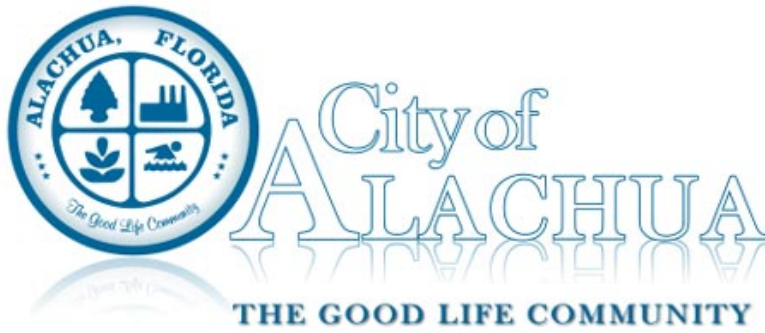

Member Potts moved to adjourn; seconded by Vice Chair Blalock.

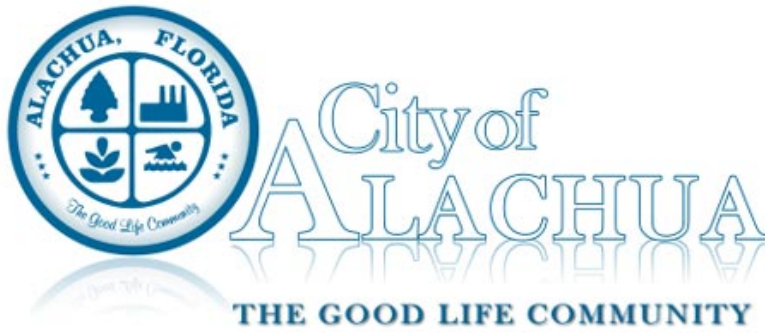
